STUD SERVICE AGREEMENT AND CONTRACT

These terms and conditions are entered and agreed upon by both Stud Owner and the Owner of the Bitch, who acknowledge the moral and legal worth of this contract.

AGREEMENT

In consideration of a stud fee of _____, the Stud Owner agrees to breed the above-named Stud Dog

_____ to the above-named Bitch _____ with the following conditions subsequent:

GUARANTEES BY THE **STUD OWNER**

1. The Stud Owner will attempt to get successful breedings on this bitch.
2. If the bitch fails to conceive, the Stud Owner will offer a repeat stud service on the bitch's next season. This repeat service **ONLY** applies to the dog and bitch named above in this contract.
3. If the bitch does not whelp at least (ONE) live puppy (live being defined alive on the date eight weeks after the birth), the Stud Owner will offer a repeat stud service on the bitch's next season or the season after that. This repeat service **ONLY** applies to the dog and bitch named above in this contract.
4. Should the above-named stud dog die or become unable to sire a litter after the first breeding attempt has failed, but before the conditions of this contract are met, the Stud Owner will offer a return service from another stud males. If the Owner of the Bitch agrees, the second breeding will occur as in paragraph 3. If Owner of the Bitch chooses not to accept the return service from another stud male, the Stud Owner is released from any further obligations on this breeding.
5. The Stud Owner will furnish pedigree, medical certificates, and photos of the stud dog to the Owner of the Bitch.

GUARANTEES BY THE **OWNER OF BITCH**

1. The Owner of the Bitch guarantees that the stud fee will be paid **BEFORE** the time of breeding and accompanied by a signed copy of this contract.
2. All transportation charges and veterinary expenses incurred as part of, or as the result of this breeding shall be the responsibility of the Owner of the Bitch.

3. Should above named bitch die before this contract is fully executed, the Stud Owner is no longer obligated to give a return service. (things happen so we will work with you)

4. The Owner of the Bitch agrees that no puppy resulting from this breeding will be disposed of through pet stores, puppy mills, commercial breeders or "resale" operations. If it is found that a puppy or puppies have been disposed of in this manner, the Stud Owner's reputation will be damaged; damages of \$2500 per puppy will be owed immediately to Stud Owner. Stud Owner's reasonable attorney fees for recovery of the puppies out of this deplorable situation and/or the collection of the fine will be paid by the Owner of the Bitch.

5. The Owner of Bitch hereby releases Stud Owner of any liability for any sickness, accident or even the death of the bitch while under the care of the Stud Owner.

6. The Owner of Bitch agrees that the bitch will NOT change ownership while she is in whelp
